I was invited by the President of APRH (founders do chair the serial event in its regular 14th edition) to chair the 14 SAS.

We will seek the deep involvement of IAH members, the Portuguese Chapter, and others. From IAH we would like to have an endorsement of this event that promises high quality. It aims to review the past 30 years of groundwater outcomes, based on the previous 13 topical SAS (plus a foundational one 10 years earlier), mainly in Portugal but in an inevitable Peninsular and World context. Follows an evaluation of the state of the art and ideas and projects to cope with the immense challenges for another three decades of hydrogeoethical sustainable development with groundwater in a changing world.

If some financial support is available we would like it to support student participation, eventually an external authority for an opening or closing conference and participation in an anticipated round-table for conclusions.
